Election: Candidates are solicited from Subcontractor Member organizations and Corporate Member. The Slate of Nominees is presented by Great Plains QIN to the Corporate Member, CIMRO, for election to the Great Plains QIN Board. Directors are typically elected in April (unless a vacancy exists) and commence Board service at Great Plains QIN's Annual Meeting held in April/May.

Terms: By-Laws provide for staggered terms. Directors are elected to three year terms, and this report includes all people who served as board members during the year. Except as prohibited by any QIN-QIO Contract or Subcontract held by the Corporation, no more than three (3) Directors may serve for more than six consecutive years on the Board of Directors in which case no Director may exceed nine (9) consecutive years of Board service.

Board Compensation: Reflects the amount paid for attendance and participation in Board of Director and Board Committee meetings during calendar year 2019. Excludes reimbursable travel expenses.
